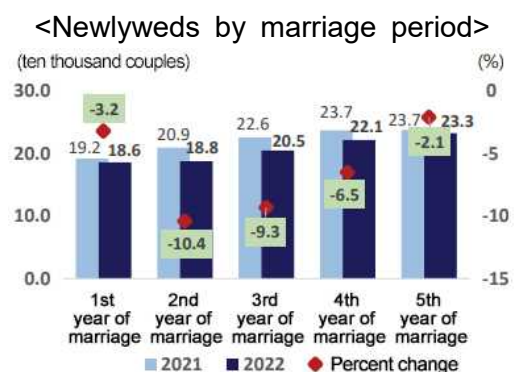
2022 Newlyweds Statistics

- based on administrative data -

1. Overview of newlyweds

□ In 2022, the newlyweds totaled 1.032 million couples, falling by 6.3% (69 thousand couples) from 2021.

○ The newlyweds in the first year of marriage dropped by 3.2% from 2021.



2. Child and child care of couples at first marriage

□ **(Child)**

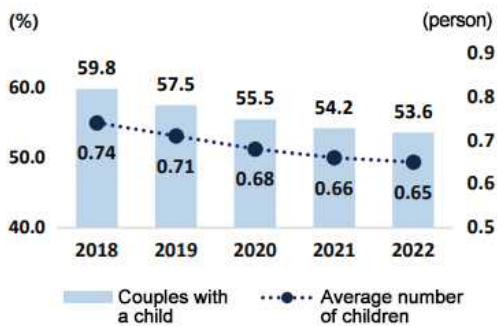
The share of newlyweds at first marriage with a child stood at 53.6%, down 0.6%p from 2021. The average number of children of newlyweds at first marriage stood at 0.65 person, falling by 0.01 person from 2021.

○ As for the share of newlyweds with a child, dual income newlyweds stood at 49.8%, which was 9.6%p lower than single income newlyweds (59.4%).

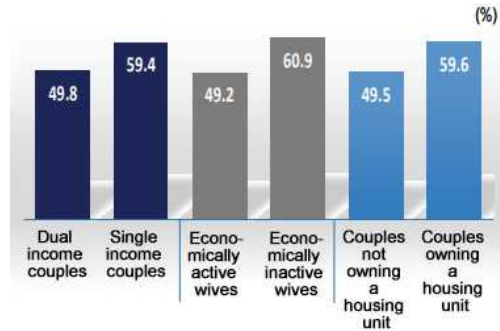
○ As for the share of newlyweds with a child, couples of economically active wives stood at 49.2%, which was 11.7%p lower than those of economically inactive wives (60.9%).

○ As for the share of newlyweds with a child, couples not owing a housing unit stood at 49.5%, which was 10.1%p lower than those owning a housing unit (59.6%).

(Child care)

As for child care of newlyweds at first marriage, 'Day care center' occupied the largest share at 51.3%, which was followed by 'Home care' (42.6%) and 'Kindergarten' (3.4%).

- As for the share of newlyweds of 'Day care center', dual income couples recorded 54.5%, which was 6.6%p higher than single income ones (47.9%).

3. Economic activity of couples at first marriage

(Dual income couple)

The dual income couples occupied 57.2% of the total newlyweds, rising by 2.3%p from 2021.

(Income)

The annual average income of newlyweds marked 67.90 million won, rising by 6.1% from 2021.

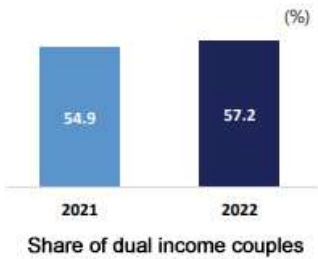
- Newlyweds earning '50 million ~ less than 70 million won' occupied the largest share at 22.0%, which was followed by those earning '70 million ~ less than 100 million won' (21.3%) and those earning '30 million ~ less than 50 million won' (20.2%).
- The annual average income of dual income newlyweds (84.33 million won) was 1.7 times higher than that of single income newlyweds (49.94 million won). The annual average income of newlyweds owning a housing unit (75.91 million won) was 1.2 times higher than that of newlyweds not owning a housing unit (62.44 million won).

(Loan)

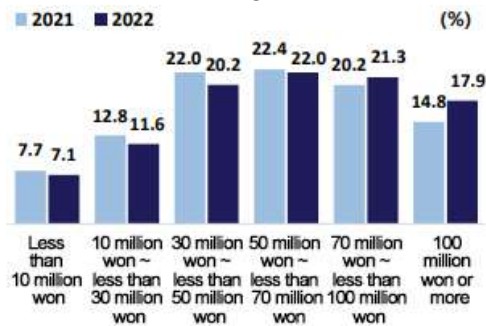
Newlyweds with loans from financial institutions occupied 89.0% of the total newlyweds, down 0.1%p from 2021.

- The median value of loans from financial institutions stood at 164.17 million won, which grew by 7.3% from 153.00 million won in 2021.

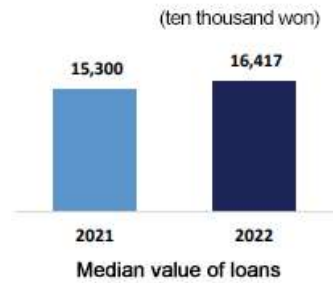
<Share of dual income couples>

4. Housing status of couples at first marriage

(Type of living quarters)

The largest share of newlyweds (72.4%) resided in apartments, up 0.3%p from 2021.

(House ownership)

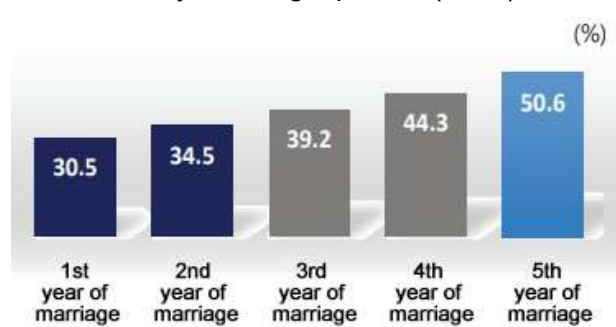
40.5% of newlyweds owned a housing unit, which decreased by 1.5%p from 2021.

- 30.5% of newlyweds in the first year of marriage owned a housing unit. 50.6% of newlyweds in the fifth year of marriage owned a housing unit. The longer marriage period, the higher share of newlyweds owning a housing unit.
